Institutional capability

1.1 About

Sneha's Care is a secular, unbiased, and self-governing development organization that is officially recognized by the Nepalese government. Sneha Shrestha, an animal rights activist whose organization has long worked for the welfare of animals, initiated a campaign in 2015 to safeguard community dogs from abuse, cruelty, and other types of mistreatment.

Sneha's Care has been working tirelessly to introduce animal welfare policies in Nepal to safeguard the welfare of animals and ensure penalties for any animal abuse and cruelty, along with running the shelter. Additionally, Sneha's Care intensively promotes animal welfare awareness on a national level and educates people to have compassion for all animals.

In order to serve diverse communities, governmental and non-governmental organizations for the welfare of the animals, it has been providing workshops and training services. It offers a variety of institutions its educational and awareness services.

1.2 Mission

Sneha's Care advances the vision to build a humane community that promotes compassion through the humane treatment of animals, humane education, and community service. Our mission has always been to save animals by providing them the life they deserve and improving the conditions of their existence whether they are ill, injured, or abandoned.






Shelter Activities

Animal Birth Control (ABC)

Sneha's Care has been working in community dog population management since 2015. In order to manage the program more collaboratively, we moved forward alongside with several Lalitpur district ward offices. Standard practice of Catch-Neuter-Vaccinate-Release (CNVR) is passed down which is a humane method of managing dog populations which involves humanely trapping or catching dogs, bringing them to the shelter, neutering them, vaccinating them usually against rabies, and returning them to the exact location where they were caught 3 days later. The CNVR process also includes deworming.

A V-shaped notch was created on their left ear to identify them as sterilized. We were able to sterilize 1,193 community dogs and cats this year from different parts of Kathmandu valley and Lalitpur district mainly targeting LMC, GD, and ML. We have significantly helped to reduce and manage the population to some extent during this year.











Shelter Activities

Mobile treatment

One of the main causes of the rising number of accidents is the increasing population of community animals.

The random and unmanaged dog population and abandonment of calves and cows in the streets are often encountered in vehicle accidents, sometimes found with the intense diseased condition, CTVT, CPV, many more. Through our mobile treatment program, we consistently work to assist animals in need of treatment. Sneha's Care Mobile treatment team comprises a veterinary doctor, helpers, and assistants, who have been working around the clock to provide necessary treatments and care to the needy community animals. We receive calls and texts on social media, hotlines, and emails on daily basis from numerous people on the topic of community animals who require help. Our team is always dedicated and responsive to rescue and treat the animals in need. With the help of a vet ambulance. we rescue the animals to our clinic inside the shelter for proper examination and stabilization and if needed for long-term treatment. The main aim of this program is to treat animals in need and sensitize the community about the welfare of animals. Through this program we have been able to spread an awareness to people for being responsible towards the well-being of animals present in their locality. Dissemination of flyers and bookets have aided in making people understand about cases related to rabies, injured and care to sick ones. This year we were able to help and support 1,587 animals including in-field, shelter treatment and rehabilitation.







Shelter Activities

Anti-Rabies Vaccination

Rabies remains a significant global health problem. Humans and animals are at risk of contracting rabies. One major problem with rabies prevention is a lack of basic life-saving knowledge among people at risk. Public awareness, responsible pet ownership, and control of community animal populations are crucial in reducing the risk of rabies transmission and ensuring public health safety.

Sneha's Care has been conducting anti-rabies vaccination campaigns in different wards of Lalitpur Metropolitan City.

With the theme, "Zero By 30", we are focusing on LMC to make zero rabies cases in the Metropolitan by the year 2030. There are more than 10,000 dogs in Lalitpur and 50% of the dogs have been provided with the anti-rabies vaccination. We have been dedicated towards making "rabies and babies free Lalitpur" by 2030.

Engaging the community through the distribution of informative pamphlets during our vaccination program was essential in reaching and informing as many people as possible about rabies.

Our grateful donors and government partners supported our work in vaccinating 4413 dogs in the community. We were also able to rely on the community's help in locating of dogs and helping with vaccinations during the campaign.

Rescue and rehabilitation

We receive numerous calls and messages about hit-and-run, animal abuse, abandoned ones, and dogs getting territorial on a daily basis. Our mobile treatment team initiates treatment for sick and injured animals and keeps them in the shelter until complete recovery. After complete recovery, they are sent back to their community being spayed/neutered. Cases like paralyzed ones and those who are unable to survive in the community further stays in the shelter lifelong.

The careless abandonment results in thousands of helpless cows left roaming the streets of Nepal. Community cows have emerged as a major problem across Nepal. There are around 10,000 abandoned cows in the valley alone. The abandoned cattle roam the streets of Kathmandu, Lalitpur, Bhaktapur causing traffic problems and suffering from malnutrition, dehydration, and injuries from road accidents.

Sneha's care has been providing treatment and rehabilitation to these animals for the past 8 years now. We have rescued such abandoned cows, calves and farm animals with illness. We now care for 170+dogs, 17 cows, 2 buffaloes, 7 pigs, 7 goats and 1 sheep. When we come across cases like pelvic fractures, heavy parasite infestation, and systemic diseases, those could not make it but majority of them were treated and are rehabilitated at our shelter.

Rescued rabid-suspected dogs



Rabid-suspected dogs are rescued into our shelter and kept in isolation after receiving letters from wards about complaints of an aggressive dog biting residents. This is done in order to prevent the dog from being mercilessly killed and to determine whether the dog is suspected of having rabies or whether it is simply acting aggressively and needs birth control surgery. There are numerous instances where dogs simply need a little tenderness and love from community people so that the dog does not tend to be aggressive. We have been raising awareness through distribution of leaflets and pamphlets on how animals deserve love and care. Making people responsible for providing basic needs like food and water and certain medicines at times of minor skin issue cases for the animals who are in need. Overall, in coordination with the LMC, Sneha's Care is being able to help numerous dogs in the community for which we are grateful and hopeful towards LMC and community people for coordination.

Rescued sheep and goats

There are numerous goats and sheep offered to the Lord Kalbhairav, Basantapur. These offered and abandoned lives are usually seen roaming around the temple, having neither proper food to eat, nor water to drink. This actually deteriorates their health. We had been informed about them and with the coordination of the concerned government body, we rescued them from their miserable life and brought them to our shelter. After their physical examination, it was known that most of them were dehydrated and extremely ill. They were provided with proper medications and treatment after being rescued into the shelter. We have been coordinating with the government for their welfare.

INSIGHTS INTO THE PROJECTS

Project Activities



School outreach

VEGAN EDUCATION SESSIONS

The project aimed to educate young non-vegan students about the benefits of plant-based diets for their own health, the betterment of the environment, and for the welfare of animals. We conducted a school outreach program to raise awareness among children and sensitise them about the benefits of veganism. The program included orientation on vegan diet options, a question answer round and various types of videos on animal cruelty was shown. At the end of the session a compassion club was formed , and participants and their parents were given a tour of the shelter and animal farm, along with free vegan breakfast and lunch.

The project's objectives were to help students build empathy towards animals, to foster awareness about Veganism and to offer knowledge on plant -based diets. The project outcomes were positive, with participants gaining an insight into the benefits of plant-based food choices. In the context of 2022, we have reached out to a total of 110 Schools in Kathmandu and Lalitpur area. The project effectively conveyed the message that all living beings are the same, and it was successful in achieving its objectives and had a positive impact on the participants.

Vegan Community Outreach Movement

Since 2018, Sneha's Care has been devoted to promoting plant-based diets throughout Kathmandu valley. Our Veganism & Community Outreach Movement (VEGCOM) project specifically engaged women co-operatives, women self-help groups and mothers' groups to provide education on the advantages of a vegan lifestyle; not only for human and animal welfare but also in terms of improved health and environmental sustainability. Additionally, we have conducted numerous workshops and held a VegFest on a community forum with the aim of reducing the usage and consumption of animal products. The overwhelming success of our venture demonstrates that plant-based foods contain the nutrients required for a healthy life, in exclusion of animal products, consumption can improve both health and the environment whilst upholding greater animal rights. We, at Sneha's Care, believe that everyone should benefit from this knowledge.

Welfare in Dairy Cattle Farm Industries (WELFARM)

The development of the dairy industry in Nepal is projected to have major growth potential in the coming years. Over 500,000 people are employed in this sector and 1,700 dairy cooperatives produce hundreds of liters of milk every day. There has been an influx of foreign investment and a policy implemented by the government to double milk production within four years. Despite this significant progress, it is essential that animal welfare standards and regulations are established before further expansion takes place as current legislation does not include provisions for this. The livestock industry is already responsible for 63% of Gross Domestic Product (GDP) in Nepal; achieving efficient and ethical levels of growth can only be beneficial to all stakeholders involved.


The number of dairy farms has been increasing, and unfortunately the associated animal cruelty has been on the rise as well. There are numerous accounts of poor animal welfare such as farmer's abandon unproductive cows and male calves that suffer from starvation, thirst, pain, and diseases.





These animals have further caused an uptick in road accidents. Local government bodies and rural communities remain intact on animal welfare regulations, resulting in municipalities resorting to inhumane methods of dealing with abandoned animals. Hence, Sneha's Care assesses the need of intervention and work on this matter to improve the welfare condition of dairy industry in Nepal.

This project has been focusing on creating awareness among government stakeholder of federal as well as provincial for the development of dairy animal welfare standards that prevent cruel practices inflicted upon animals used for milk production. In 2022, Sneha's Care became successful in making a significant accomplishment: the province of Gandaki had completed their dairy animal welfare standards and other provinces are following in its footsteps. We have worked tirelessly to collaborate with provinces to formulate such dairy animal welfare standards and effective implementation of dairy animal welfare standards.

We have been collaborating with the local government entities to help solve circumstances where many community animals encounter issues on a daily basis. We frequently receive letters from various ward offices requesting our assistance in resolving incidents, involving aggressive dogs biting people, as well as in helping them to vaccinate their community dogs against rabies and implement animal birth control programs. From rescuing the animals with critical cases like hit-and-run to bringing in the abandoned calves into the shelter, our organization has been dedicated towards serving animals who are in need including their welfare.

Lalitpur Metropolitan City (LMC) has prioritized animal welfare in its upcoming plans and programs. Sneha's Care delegation met Mr. Chiri Babu Maharjan, our honorable mayor of LMC, for developing LMC as an animal friendly metro.

An MOU with Lalitpur Metropolitan City also has been signed where both parties have agreed to make LMC an," Animal Friendly Zone". LMC has pledged to support us in any way they can in our efforts to aid animals.








Fighting for the humane treatment of animals and preventing them from their sufferings has always been the main objective for Sneha's Care. Making a difference for animals by protecting them from animal cruelty and abuse through advocacy is the goal of our organization.

From raising awareness for banning live animal transportation acts, to protesting and giving justice to the culprit of the dog killing case, we are always dedicated to become a voice for animal rights and welfare. Tarkeshwar Dog Killing CaseThe incident took place on 2nd of August, 2022 in Tarkeshwar municipality-4, Kathmandu, where a local was seen murdering a dog brutally while the dog was asleep. With constant effort from the animal activists and welfare organizations, we were able to punish the culprit with a fine of Rs.3000 and locked-up in prison for 2 days. Though the punishment was not according to the implemented law, change has taken place and slowly, we believe, with consistency and perseverance, animal law and standards will be followed by all.







Our Attempts to Ban Long Distance Live Animal Transportation

The Animal Transportation Standard, 2007 is a set of regulations established by the Nepal Government to ensure the humane treatment of live animals during transportation. However, the enforcement of these regulations may be challenging in rural areas. Live Animal Transportation can cause harm to animals , public health, and the environment through stress, illness , injury, death, disease spread, and pollution.

Sneha's Care has been campaigning for awareness and advocating for stricter laws and alternatives to Live Animal Transportation, collaborating with international organisations, and monitoring animal quarantine check posts. Violations of government standards during transportation were found, including overcrowding, lack of food and water, use of ropes causing injuries, mixing animals of different ages and physical conditions causing stress, overstacking of goats leading to suffocation and exhaustion and unmanaged execution processes.

Since the program's commencement, we have trained government representatives on how to properly manage the transportation of animals. We have also assisted enforcement agencies by setting up checkpoints and by providing necessary materials. Our team is always alert and are present in the checkpoints every now and then during night time, to check whether the cruelty has reduced or still is neglected. Sneha's Care wants to make this program available to all provinces nationwide and ban animal cruelty in transportation.







The Last Dancing Bear was rescued by Sneha's Care with the help of local police from Danda Tole, Lahan Municipality, Siraha district, overnight in 2019 after being informed about the torture it had been facing by the locals.

A year old male sloth bear(belonging to India) was seen giving a dance performance in the small village in Siraha. The bear was initially given to its owner in the form of Dowry by his in-laws from India. Primitively, when it was first found, it was in poor health, he was tied by a rope in his muzzle with a metal rod.

With a belief that they belong in the wild rather than being used for entertainment purposes and not to deprive from their freedom, Dhuturu was rescued and brought to Kathmandu, it is now being kept in Central Zoo and is in the process of being translocated to Agra Bear Rescue Center, Uttar Pradesh, India. Our team keeps visiting the zoo to check whether Dhuturu is in good condition. Since 2019, we have been trying to send back Dhuturu but due to various reasons and also due to COVID, the process of sending back Dhuturu got halted. We have been lobbying with the Ministry of Forest and Environment, along with the Ministry of Home Affairs. Meetings have also been held with the Home Minister, Forest Minister and concerned bodies regarding this matter. Up until Dhuturu is returned to his natural habitat, we will continue to advocate for him. Hopefully, Dhuturu will be back to his real habitat where he can live the rest of his life peacefully with full freedom.

Sad Stories:



Malnutrition: A curse for community animals

No dog deserves to live on the streets, unsure of where their next meal will come from or if they'll be hit by a car. Unfortunately, this is the reality for many pups. These dogs were skinny and weak from lack of proper nutrition, and had a severe skin condition. They had been rescued and brought to our shelter. Some of them has been undergoing required treatment, and for some we did everything we could to help him, but sometimes, it's just not enough.



Rabies(Incurable after being infected)

It's tragic that rabies is still such a problem in many communities. Rabies is a serious virus that can infect any mammal, and is fatal to both humans and animals if left untreated. The dogs were rescued after being found with similar symptoms of rabies. They were then rescued, isolated in an attempt to prevent the virus from spreading, but unfortunately most of them succumbed to the disease and passed away. These are the tragic examples of how dangerous rabies can be, and how important it is to address it on time. This year we have addressed 18 cases of rabid dogs.



Skin Issue: Relentless scratching results in wounds and bleeding

Skin diseases can cause physical pain, discomfort and even disfigurement. Moreover, it is not uncommon for the dogs to become sad and miserable due to the skin issues they are facing. The most common skin diseases seen in community dogs include mange, flea allergies, bacterial infections, fungal infections and various types of dermatitis. It is important to provide them necessary care as soon as possible when these conditions are discovered in order to reduce suffering and ensure that the dog is able to live a comfortable life. We have addressed a lot of skin issues and have been able to help a lot of community dogs to get a better life.



Hit/Run(Rajkumari, dragged by a truck after being hit)

Hit and run accidents are a sadly common occurrence, and all too often they involve our furry friends. Community dogs are often struck by vehicles while they are out in the roads to scavenge for food and the results can be devastating. Injuries sustained in a hit and run accident can be severe, and often prove fatal. Dogs who are hit by vehicles and left to fend for themselves face a long and painful recovery, if they are lucky enough to survive at all. We've handled many severe hit and run cases that required shelter treatment by rescuing them.

Human Cruelty (Kunti was stabbed by a sharp object)



Human cruelty towards animals is a disturbing reality that exposes the darker side of our species. Despite their vulnerability and innocence, countless animals suffer at the hands of human beings.

We come across numerous cases such as dogs being stabbed by sharp objects, pouring of hot water, acid, dropping tar in their bodies, tying their legs and drowning them in water bodies and many more. These inhumane acts needs to be stopped and we have been raising awareness against these animal cruelties.



Success Stories:

"Rupak": A young fighter who survived hit & run and canine parvo.

On April 11th, 2022, one of our team members received a report about a three-month-old male dog named Rupak who had suffered a proptosis of his left eye due to a hit and run incident. Immediately upon the report being made, the veterinary team got to work providing continual care for Rupak until he started eating on his own after three days. During this time, the protruding eye was regularly dressed as it still seemed viable. Ultimately, it was decided that surgery wasn't required at present and medication was continued for another week.

Tragically, Rupak then contracted Canine parvovirus: which is particularly likely in unvaccinated puppies, although thankfully he developed strength and courage to fight back against it with treatment followed by another week of intensive care at the shelter. Unfortunately the trauma has resulted in the shrinking of Rupak's eye. As he would have difficulty surviving on the streets again due to his condition, he will be staying in the shelter.









Chased away for bleeding

Leo, a friendly dog, was rescued from a critical situation. His front limbs were crushed beneath the wheel of an oversized vehicle and he was even chased away by onlookers due to the mess his injuries caused. Fortunately, we at Sneha's Care soon heard of Leo's plight and our mobile treatment team came to his aid right away.

Though his wounds recovered fairly quickly, one of his limbs required some extra care during the recovery process. Now that Leo is fully vaccinated, dewormed and neutered, he enjoys all the comforts in our shelter. It is good news that he has been sponsored recently.

Defeated Death

Innocent soul, Raja had to be a victim of a hit-and-run case, where people who witnessed, this accident were shocked to know that he was still breathing. He was hit by a vehicle at such a speed limit that he landed a few meters away from the spot, damaging his brain as well as leaving him covered in blood. Niraj Thapa from Imadol, ward-2 informed me about Raja on August 24.

He was not in a state of consciousness for almost a week as he was going through brain trauma due to his head injury and was experiencing seizures. There was less hope of his survival but he is a survivor who defeated death. His wounds are healing but due to the injury, his head is slightly tilted towards the left and unfortunately will stay like that forever. He has recovered completely an dis getting healthy as time passes by, we feel he needs proper care for his remaining life, so we are planning to get him a loving home or he shall stay with us in the shelter.







Khairi gets a second chance at life

Khairi, a community canine, had been living in the streets of Godawari for seven years. Though it was impossible to miss her large tumor and maggot infestation due to their conspicuous size over time, little was done to alleviate Khairi's suffering. Fortunately, kindhearted local Purna Prasad Timalsina brought Khairi into our shelter on August 7th for treatment.

Given Khairi's old age and the tumor's weight of almost a kilogram, surgery posed a risk. Upon being kept under medication for 4-5 days until stable, the operation was successful. Thereafter she made remarkable progress leading up to her eventual return back to her community home with Mr. Purna's excited accompaniment a few weeks later. We are thankful to all parties involved in saving this innocent animal from such unfortunate circumstances and providing her comfort and safety.
